BRIEF WRITE UP ON THE OPERATION AND PAYMENT SYSTEM

Lanka IOC PLC wishes to appoint a Bitumen Credit Facilitator for the purpose of providing Credit Facility to its Credit Customers. Upon the identification of the Credit Customers, Lanka IOC shall inform the Credit Facilitator in writing the details of the Credit Customers. Simultaneously with the provision of the details of the Credit Customers to the Credit Facilitator, Lanka IOC shall communicate to each Credit Customer the description of the Credit Facility and provide a copy of such communication to the Credit Facilitator. The credit facilitator also on their own may solicit new customers and inform LIOC on identification of the same.

The Credit Customer shall send the Purchase Order to Lanka IOC and Lanka IOC shall send the same to the Credit Facilitator.

Immediately upon the receipt of the Purchase Order and in any event within a period not later than seven days, the Credit Facilitator shall make the payments specified in the Purchase Order to Lanka IOC in full. In the event that the Credit Facilitator is unable to make payments as aforesaid, the Credit Facilitator shall forthwith inform Lanka IOC and the relevant Credit Customer of its inability in writing. Credit facilitator shall also raise a delivery order on LIOC authorising LIOC to supply products to the concerned party.

As soon as the payment from the Credit Facilitator along with the Delivery Order for the Purchase Order is received, Lanka IOC shall supply the Products as per the specifications set out therein to the Credit Customer and issue an invoice to the Credit Customer with the Credit Facilitator or its nominated Financial Institution as the assignee of the payments to be made under such invoice.

After acceptance of the Products supplied by Lanka IOC by the Credit Customer by acknowledging the invoice issued by Lanka IOC for the Products in two original counterparts, the title to the Products shall pass to the Credit Customer and the said products shall thereafter be at the risk of the Credit Customer.

Lanka IOC shall provide one original counterpart of the invoice issued by it acknowledged by the Credit Customer to the Credit Facilitator upon receipt thereof.

The Credit Facilitator shall settle all amounts paid by it under the provisions hereof from the Credit Customer under and in terms of an agreement entered into by and between the Credit Facilitator and the Credit Customer.

The Credit Facilitator acknowledges that Lanka IOC shall have no liability whatsoever in respect of any non payment, losses, costs, claims, damages, expenses, fines, liabilities and penalties suffered by the Credit Customer arising from or relating to the Credit Facility except as expressly provided herein.

In consideration of the services provided by the Credit Facilitator, Lanka IOC shall pay a fee as determined by Lanka IOC towards credit cost and service charges. The minimum fees

The fees shall be reviewed from time to time and adjustments to the fees shall be negotiated and agreed upon by the parties in view of the fluctuations of the monthly figures of the Average Weighted Prime Lending Rate calculated and published by the Central Bank of Sri Lanka above 100 basis points.

The Credit Facilitator shall forward a detailed schedule of payments collected by it from the Credit Customers during the month on or before 3rd of the succeeding month.
