b.	We, further, agree that the guarantee herein contained shall remain in full force and effect upto and until the date of completion of the warranty period mentioned in the Contract which is 12 months from date of shipment, provided always that notwithstanding anything heretofore contained the liability of the Bank hereunder shall remain valid till after which date it will automatically lapse unless a demand is made by the LIOC before that date.	
C.	Although as between the Bank and Suppliers the Bank is the guarantor only, the Bank agrees and confirms that as between itself and the LIOC, the bank shall be primarily liable for the payment of the amount/s that may be claimed by the LIOC by virtue of this guarantee and that the Bank shall be treated as the principal debtor.	
d.	We further agree that the LIOC shall have the fullest liberty without affecting in any manner our obligations hereunder and without reference to us to vary any of the terms and conditions of the said Contract and / or to extend time of performance by the Suppliers from time to time or to postpone for any time or from time to time any of the obligations of the Suppliers or powers exercisable by the LIOC against the Supplier and / or forbear to force any of the terms and conditions of or relating to the said Contract and that we shall not be released from our liability under this Guarantee / Undertaking by reasons of any such variation or extension being granted to the said Supplier or for any forbearance and/or omission on the part of the LIOC or any indulgence by the LIOC to the Supplier.	
e.	The Bank will not require any proof or judgement, document, decree or any direction from any Court/Arbitrator or otherwise to substantiate the claims of the LIOC against the Suppliers. The right of the LIOC under this Guarantee will not be affected by reason of any pending proceeding before any court or Arbitrator.	
f.	Notwithstanding anything contained herein before our liability under this Guarantee is restricted to Rs	
g.	We further agree that this Guarantee shall not be affected by any change in the Constitution of the Bank or the Suppliers.
